Reimbursement and Budget Updates

Status of January 1, 2023 Final Rate Letters Released

As reported earlier this month, the January 1, 2023, final rate letters were posted to the Myers & Stauffer portal on August 24, 2023. MO HealthNet keyed the new rates into the system on August 28, 2023. As such, for all Medicaid days billed after August 28, 2023, the rate will be paid at your facility's January 1, 2023, SNF Medicaid rate.

The state is still working on a timeline for making any mass adjusted retroactive payments back to January 1, 2023, for facilities who have incurred an increase to their Medicaid rate. Likewise, we are still working with the state to determine how and when they will handle any recoupment of overpayments to facilities as a result of decreases to facility rates effective January 1, 2023.

As a reminder and as we have previously reported, facilities may see significant increases to their January 1 rate as a result of increases to their CMIs. Facilities may also see significant decreases in their rate as a result of decreases to their CMI. Some facilities may see little to no changes in their rate.

<u>Please Note</u>: This is the first adjustment since the state incorporated CMI and VBP incentives into the SNF Medicaid rate plan. This should give facilities a glimpse of how important it is to properly capture acuities on their MDS and the impact acuities will have on their rates.

As soon as we learn any additional information regarding the mass adjusted payments or recoupments, we will report that to the membership.

Status of July 1, 2023 CMI/VBP Rate Adjustment and \$10/PPD Increase

The state is still in the process of calculating the July 1, 2023, rate adjustments based on changes in CMI and the Value Based Payment incentive. MO HealthNet will be releasing resident listings for facilities to review and correct any mistakes in their MDS's. MoHealth Net does not know exactly when they will have the data ready to release the resident listings but anticipate it will be ready to release sometime in the next month or so. We will keep you updated as we learn more.

In addition, the \$10/PPD rate increase and increase to the VBP incentive effective on July 1, 2023, will not be able to be paid to facilities until CMS approves the state plan amendment. We have no idea when CMS will approve the increase, but historically, a simple across the board increase like this usually is approved in the late November/December time frame. Once we have any feedback from the state and CMS on the timeline, we will share that with the membership. We don't anticipate approval until closer to the end of the year.

Legislative Update

PLEASE consider hosting your legislators for a tour of your facility. As we discussed at the MHCA Convention earlier this week, hosting facility tours or reaching out to your legislators to explain the dire need to rebase our SNF Medicaid rate based on post-COVID costs is imperative to our success securing another rebase during the 2024 Legislative Session. Sarah Henke will be reaching out to facilities in legislative districts represented by key budget leaders in both the House and Senate; however, it is imperative that all our facilities reach out and host their legislators to discuss the financial, workforce and other challenges plaquing our sector.

It's a great strategy to let legislators have first-hand experiences of the care you provide in a SNF. This gives them a great perspective and they will rely on your expertise in this industry prior to making decisions that impact your operation. We can't express enough how important these facility visits will be to our future reimbursement and other legislative successes. If you do host legislators, please share your experience so we can highlight your advocacy efforts on social media and in the newsletter!

CDC Released New Resources on Enhanced Barrier Precautions

The CDC has released new resources to assist nursing home staff with understanding the benefits of and implementing Enhanced Barrier Precautions (EBPs). Multidrug-resistant organisms (MDROs) are a known threat to nursing home residents; these germs can cause serious infections that are often hard to treat. EBPs are infection prevention and control practices that can help reduce the spread of MDROs in nursing homes and protect residents. These new resources will help staff, residents, and loved ones learn more about why EBPs are important and when these practices should be used.

COVID-19: CPT Codes for Vaccines No Longer Authorized

The Food and Drug Administration (FDA) recently announced more vaccines no longer authorized for use in the United States. Medicare doesn't pay for the following CPT codes effective:

- June 1, 2023, Janssen: 0031A, 0034A, and 91303
- April 18, 2023, Moderna: 0011A, 0012A, 0013A, 0064A, 0091A, 0092A, 0093A, 0094A, 0111A, 0112A, 0113A, 91301, 91306, 91309, and 91311
- April 18, 2023, Pfizer, 0001A, 0002A, 0003A, 0004A, 0051A, 0052A, 0053A, 0054A, 0071A, 0072A, 0073A, 0074A, 0081A, 0082A, 0083A, 91300, 91305, 91307, and 91308

Regulatory Updates

Collecting Healthcare Personnel Influenza Vaccination Data for Long-Term Care Facilities to Prepare for the 2023-2024 Influenza Seasons

Below is some key information to help long-term care facilities (LTCFs) prepare for collecting annual healthcare personnel (HCP) influenza vaccination summary data for the upcoming influenza season.

Which facilities are required to report these data?

• CMS-certified skilled nursing facilities (SNFs) are required to report HCP influenza vaccination summary data through NHSN.

What data is submitted?

• The reporting period for the 2023-2024 influenza season is from October 1, 2023, through March 31, 2024. Facilities are only required to submit one report that covers the entire reporting period.

How should facilities submit these data?

• Facilities must report **annual HCP influenza vaccination** summary data through the NHSN **Healthcare Personnel Safety (HPS)** Component.

Who can activate the HPS Component?

- Only the NHSN Facility Administrator (FA) can activate a new component. The NHSN FA can then add users, including the HPS Component Primary Contact, once the component is activated.
- If the NHSN FA leaves the facility but does not transfer the role of FA to another individual prior to leaving, please complete the NHSN Facility Administrator Change Request Form: https://www.cdc.gov/nhsn/facadmin/index.html.
- Please do not de-activate any other NHSN Components, such as the LTC Facility Component.

What is required for LTCFs to access the HPS Component?

Level 3 access is required to activate the HPS Component. If you do not currently have Level 3 access, you will receive an invitation to Level 3 reporting by September 1, 2023, via e-mail. For additional questions, please send an e-mail to NHSN@cdc.gov and place "SAMS Level 3 Access" in the e-mail subject line.

CMS Releases Final Version of MDS 3.0 Item Set

In August 2023, CMS released the updated final Minimum Data Set (MDS) 3.0 Item Sets version (v) 1.18.11 and it is now available in the Downloads section on the Minimum Data Set (MDS) 3.0 Resident Assessment Instrument (RAI) Manual page. All item sets have been replaced with revised versions. This will be the final version of the MDS Item Sets v1.18.11 that will be effective beginning October 1, 2023.

Outpatient Rehabilitation Claims with Reason Code W7072: Do You Need to Resubmit Claims?

CMS recently indicated that Medicare Administrative Contractors (MACs) have returned some institutional, outpatient physical and occupational therapy or speech-language pathology claims with reason code W7072 in error between January 1 – June 30, 2023.

The MACs will not automatically reprocess these claims. Provider billing staff should resubmit claims that were returned in error. These claims include:

- CPT codes: 98980, 98981 (either or both)
 - CPT code 98980 Remote therapeutic monitoring treatment management services, physician/other qualified health care professional time in a calendar month requiring at least one interactive communication with the patient/caregiver during the calendar month; first 20 minutes; and
 - CPT code 98981 Remote therapeutic monitoring treatment management services, physician/other qualified health care professional time in a calendar month requiring at least one interactive communication with the patient/caregiver during the calendar month; each additional 20 minutes (list separately in addition to code for primary procedure).
- Revenue codes: 42x, 43x, or 44x
- Type of bill:
 - 22X or 23X: skilled nursing facilities
 - 34X: home health agencies
 - 85X: critical access hospitals

Staffing Agency Rules Will be Effective September 30

On August 28, 2022, Senate Bill (SB) 710 became law requiring supplemental health care service "staffing" agencies to register with the department if such agency provides or procures temporary health care personnel to a licensed hospital or a licensed assisted living facility, intermediate care facility, residential care facility, or skilled nursing facility.

The Supplemental Health Care Services Agency (SHCSA) Rules will become effective on Saturday, September 30, 2023, and the Department tentatively plans to begin accepting registration applications for SHCSA's on Monday, October 2, 2023. The Department is currently working to finalize an online registration application system and will send out further guidance to agencies and health care facilities once this has been completed.

CMS Releases New Dementia Care Model Guide to Better Support Caregivers

CMS has released the <u>Guiding an Improved Dementia Experience (GUIDE) Model</u> aimed at improving the way dementia care is delivered and supporting unpaid caregivers. The goal is to help those living with Alzheimer's disease and dementia remain in their homes and communities, thereby minimizing hospitalizations, post-acute and long-term care through improved care coordination and management, caregiver education and support, and respite services. This is part of the Biden Administration's goal to <u>increase high quality care and support caregivers</u>. Through GUIDE, CMS will test an alternative payment for participants that deliver key supportive services to people with dementia.

This announcement included some basic model parameters with additional details to be included in the Request for Applications (RFA) released this fall. **CMS is accepting letters of interest for the GUIDE Model through September 15**, **2023**.

- Guide participants will be Medicare Part B enrolled providers/suppliers, excluding durable medical equipment (DME) and laboratory suppliers, who are eligible to bill for Medicare Physician Fee Schedule services and who agree to meet the care delivery requirements.
- Participants who can't meet the GUIDE care delivery requirements alone are able to contract with other Medicare providers/suppliers known as "Partner Organizations" to meet the care delivery requirements.
- There are two tracks, one for established programs and one for new programs (those that do not have prior APM experience or comprehensive dementia care programs).
 - Established programs are required to have an interdisciplinary care team, including a care navigator, use a certified electronic health record platform, and meet other care delivery requirements as outlined in the RFA.
 - New programs must not be operating a comprehensive community-based DCP at the time of model announcement and will have a one-year pre-implementation period to establish their programs.
- The GUIDE model also incorporates strategies to improve health equity, a Biden Administration key
 priority, such as requiring participating providers to implement health-related social needs (HRSN)
 screenings and referrals, offering financial and technical support for new dementia care programs
 targeted to underserved areas, a health equity adjustment to the model's per member per month care
 management payment to provide additional resources to care for underserved beneficiaries.

The model will launch on July 1, 2024, and run for 8 years. CMS has also provided links to the GUIDE model infographic, fact sheet, and the GUIDE webpage.

CMS continues to double-down on the <u>goal</u> to have 100 percent of people with traditional Medicare in accountable care relationships with providers who are responsible for the quality and total costs of their care by 2030. The main driver for CMS continues to be their ACO strategy and it is important for long term care providers to learn and engage.

Reminder: Compliance Deadline Approaching for Food and Nutrition Director Requirements

In August 2022, as part of the Fiscal Year 2023 Skilled Nursing Facility (SNF) Prospective Payment System Final Rule (CMS 1765-F), CMS added new regulatory language related to food and nutrition services at 483.60 (a)(2)(i)(E). AHCA/NCAL previously <u>communicated</u> to members about these regulatory changes. This is an additional reminder as the October deadline approaches.

CMS created an additional pathway for the Director of Food and Nutrition to qualify for the position. This pathway includes:

- Having two or more years of experience in the position of Director of Food and Nutrition Services in a nursing facility setting
- Completing a course of study in food safety and management by no later than October 1, 2023. Course topics integral to managing dietary operations include, but are not limited to, foodborne illness, sanitation procedures, and food purchasing/receiving.

In addition, AHCA/NCAL wants to clarify several key points in relation to the Director of Food and Nutrition Services to assist providers with meeting this requirement:

- An assistant director, supervisor, or manager of Food and Nutrition Services or other related titles/roles can qualify as having "two or more years of experience in the position of director" if the individual's defined role and the duties they performed in that role comply with the requirements. Titles, such as director, supervisor, or manager, are often used interchangeably and can vary.
- The requirement to have two or more years of experience in the position noted can have occurred at any point before the final rule effective date of October 1, 2022, to meet the qualification requirements.
- Facilities that would qualify as a "nursing facility setting" for the purposes of this federal requirement can vary as long as the experience supports the individual's ability to serve in the position in the long-term care setting.

CMS has noted that the course requirements would be the equivalent of a ServSafe Food Manager certification. Providers need to enroll in and complete the required training before October 1, 2023, to qualify for the role if using this new pathway to meet qualifications.

CMS Issued FY2024 SNF Final Payment Rule

CMS has issued the <u>final rule</u> for the skilled nursing facility (SNF) prospective payment system (PPS) fiscal year (FY) 2024 update. AHCA has provided a <u>summary</u> of the final rule. Please note that a member log-in is required to view the summary. Please contact the relevant subject matter expert listed in the summary with any questions. The highlights include:

- The final rule provides for a **net market basket increase for SNFs of 4.0 percent** (approximately \$1.4 billion) beginning October 1, 2023. This is 0.3 percent more than was originally proposed in April. This positive outcome is a result of the hard work of AHCA members and staff who worked on this issue year-round.
- This 4.0 percent market basket update, after rounding, reflects:
 - A \$2.2 billion increase resulting from the 6.4% net market basket update to the payment rates, which is based on a 3.0% SNF market basket increase plus a 3.6% market basket forecast error adjustment and less a 0.2% productivity adjustment; and
 - A negative 2.3%, or approximately \$789 million, decrease in the FY 2024 SNF PPS rates as a result of the second phase of the Patient Driven Payment Model (PDPM) parity adjustment recalibration.
- Consolidated Billing: CMS finalized, as proposed, the addition of marriage and family therapists and

mental health counselors to the list of practitioners whose services are excluded from the consolidated billing provision, effective January 1, 2024.

SNF Quality Reporting Program (QRP):

- CMS is adopting two measures, removing three measures, and modifying one measure.
- This rule makes policy changes to the SNF QRP and begins public reporting of four measures.
- CMS is not adopting the CoreQ short-stay discharge measure that was proposed in April 2023.

SNF Value-Based Purchasing (VBP):

- CMS is adopting four new quality measures, replacing one quality measure, and finalizing several policy changes in the SNF VBP Program.
- CMS is increasing the payback percentage policy under the SNF VBP program from the current 60% to 66% to increase bonuses provided to the high-performing, high duals SNFs beginning in the FY 2027 program year.
- **Civil Monetary Penalties:** The final rule eliminated the requirements for facilities to actively waive their right to a hearing in writing in order to receive the 35% penalty reduction and created in its place a constructive waiver process that would operate automatically when CMS has not received a timely request for a hearing.

Administrator Update Information Changes

Missouri regulation - 19 CSR 73-2.130 Notice of Change of Contact Information and Missouri Administrator Employment – was changed effective **June 30, 2023.** The rule change describes the conditions and procedures for reporting change of address. The new language states:

- (1) Each administrator shall notify the board office of his/her current contact information within ten (10) calendar days of change for any of the following:
 - (A) Personal contact information, which shall include administrator license number, personal mailing address, email, and telephone number(s); and
 - (B) Missouri administrator employment, which shall include, administrator license number, facility name, mailing address, telephone number(s), and employment dates.

<u>Please note:</u> The BNHA and the Section for Long Term Care Regulation (SLCR) each have requirements for reporting a Change of Administrator/Manager in a Long Term Care Facility. Please be sure to follow the correct requirements for each.

HRSA Announces Funding to Grow Nursing Workforce

On August 10, the Health Resources and Services Administration (HRSA), an agency of the U.S. Department of Health and Human Services (HHS), <u>announced</u> more than \$100 million in awards to train more nurses and grow the nursing workforce.

The awards focus areas include:

- Helping Licensed Practical Nurses to become Registered Nurses
- Training nurses who will deliver primary care, mental health care, and maternal health care
- Addressing the bottlenecks in nurse training by supporting more nurse faculty

Listeria Outbreak Linked to Ice Cream Distributed to LTC Facilities

The CDC is currently investigating a listeria outbreak linked to "Soft Serve on the Go" ice cream cups. One sick person in this outbreak was served this ice cream cup while residing in a long-term care (LTC) facility. Therefore, the CDC is advising LTC facilities to not serve and for individuals not to eat any flavors of "Soft Serve on the Go" ice cream cups.

If you have ordered this brand of ice cream cups, the CDC recommends that you:

Check your freezers. Listeria can survive in freezing temperatures.

Throw them away or return them to where you bought them for a refund.

Call a health care provider right away if you or your residents experience any symptoms of listeria after eating this ice cream. Symptoms may include fever, muscle aches, and tiredness, as well as a headache, stiff neck, confusion, loss of balance, or seizures.

Emergency Protocol for Facilities

The Emergency Protocol was developed in 2007 for communication between long-term care homes and the Section for Long-Term Care Regulation (SLCR), in the event a disaster occurs that results in a loss of a necessary service (electricity, water, gas, telephone, etc.). This protocol was established to streamline communication so that homes can focus on what is most important - the safety and well-being of the residents.

This protocol (Emergency Protocol Handout for Facilities) provides the cellular telephone number corresponding to the region in which your home is located if you experience a loss in a necessary service - for instance Air Conditioning - that has the potential to affect resident safety or well-being. You are encouraged to contact the regional office main office telephone number during normal business hours as survey staff carry the cell phone and may be conducting a survey or inspection during working hours and may not answer immediately.

Updated List of Excluded Individuals and Entities (LEIE) Database File

The Office of Inspector General (OIG) has released its updated List of Excluded Individuals and Entities (LEIE) database file, which reflects all OIG exclusions and reinstatement actions up to, and including, those taken in July 2023. This new file replaces the updated LEIE database file available for download last month. Individuals and entities that have been reinstated to the federal health care programs are not included in this file.

The updated files are posted on OIG's website here. Healthcare providers have an "affirmative duty" to check to ensure that excluded individuals are not working in their facilities or face significant fines. As a best practice, long term care providers should check the LEIE on a regular basis.
